What does a noise assessment involve?

A competent assessor will visit your premises with a calibrated Sound Level Meter and take measurements, using standard HSE methodology, at various positions around the site where there may be a noise problem. Measurements will be taken at operator positions amongst other areas. A report will be written containing technical data on the noise generated at various points in the premises, and advice on noise control solutions will be detailed.

The report will also assess the suitability of any Hearing Protection you currently provide, or advice on which hearing protection to purchase. The Report will assess how you are meeting your obligations under the Control of Noise at Work Regulations 2005 and will contain clear, concise actions points on how to improve the noise exposure of your employees.
